THE ASSOCIATION ALSO HOSTED SIX ONLINE WATCH PARTIES, WHERE 212 PARTICIPANTS VIEWED EDUCATIONAL PRESENTATIONS TOGETHER AND DISCUSSED HOW THE IDEAS COULD BE APPLIED WITHIN THEIR INSTITUTIONS.
